- 1. The Rule Nisi granted in this matter is made final and a final order is granted:
 - 1.1. Interdicting and restraining the First Respondent, Fourth Respondent and Fifth Respondents together with any of their assigns, agents and/or associates acting under their instructions from:

Private Bag X9020,

unlawfully intimidating, threatening, interrogating and/or harming in any way whatsoever, any construction workers, employees and/or sub-contractors employed by the Applicant and/or their agent and any of the Applicant's service providers situated at the construction sites, namely ERF 8293, on the Corner of Speyer Street and Nooiensfontein Road, also known as Seckenhein Drive, Blue Downs, Cape Town and on ERF 20733, on the corner of Batley Road and Nooiensfontein Road, Blue Downs, Cape Town ("the Construction Sites");

1.1.2. unlawfully obstructing any entrances or exits to the Construction Sites by, *inter alia*, locking gates, placing any obstruction of any kind in the road leading to such Construction Sites or gathering outside of such gate leading to the Construction Sites;

1.1.3. unlawfully preventing or restricting freedom of movement of the Applicant's employees, sub-contractors and representatives or any person/s visiting the Construction Sites in any manner whatsoever;
